### **Please read this entire packet before auditioning!**

Dancer North's Performing Companies offer a wonderful opportunity for students to take their training to a higher level. Our rehearsal and performance standards are set to provide a level of professionalism for the students. Directors will teach students choreography during auditions and then select cast members for the performing season. All students should warm up independently before their audition.

Being selected as a cast member is an honor and a privilege, but it is also a commitment and a responsibility that requires a high level of dedication from both the performer and the performer's parents/guardians. Before auditioning, potential cast members must consider all other activities in which they may be involved and be willing to put their commitment to their dance company above and beyond any other activities that may conflict with the rehearsal and performance requirements. Please bear in mind while making the decision to audition that being a cast member is not just another extracurricular activity. Dozens of people, including performers, directors, and choreographers are negatively affected if all cast members are not demonstrating the same level of commitment.

Once you have reviewed this entire packet and have made the decision to audition, you need the following items turned in to the Dancer North office by **Monday, August 15<sup>th</sup> at 5:00 pm.**

- 1. Audition Application** (page 4)
- 2. Student/Parent Contract** (page 5)
- 3. \$5 Audition Fee** (exact cash requested)
- 4. Headshot or School Picture** (no larger than 4"x4")

Please do not staple your paperwork; use a paperclip or submit in an envelope. Only the requested paperwork should be submitted. Keep all other paperwork in this packet for your personal reference. Turning in the completed forms does not guarantee acceptance as a cast member. It only guarantees the opportunity to audition. No one will be allowed to audition without completed forms.

## CAST MEMBER REQUIREMENTS

1. Tap Company members must meet the following requirements in their Dancenter North Fall class registration:

**JR TAP COMPANY:** 1 Tap Technique class and the Company Rehearsal Class (which meets on Mondays from 7:15-8:15 pm with Ms. Julie Cartier)

**SR TAP COMPANY:** 1 Tap Technique class and the Company Rehearsal Class (which meets on Mondays from 6:00-7:00 pm with Ms. Julie Cartier)

2. Cast members are to maintain consistent attendance in their required classes. There may be no more than two absences from any required technique class. Classes that are made up within a 2-week period are not counted as absences. After two absences, there will be a meeting with the director to determine if continuing as a cast member is a good fit.

3. Company Rehearsal Classes are vitally important to a successful production. Every effort must be made to attend each and every class. There may be no more than two absences from Company Rehearsal Class. Absences must be submitted in advance by a parent or guardian in writing or via email to a member of the directing team prior to rehearsal. Absences due to illness should be reported immediately to the studio office. Any performer missing more than two rehearsals will be removed from the cast. There will be no exceptions. Extenuating circumstances, such as injury or illness, should be discussed with the director.

4. All dates listed in the above calendar are mandatory and cannot be missed for any reason.

5. All company members must pay a non-refundable production fee (*Jr. Tap Company: \$280.00; Sr. Tap Company: \$315.00*), which is **due no later than Monday, October 3<sup>rd</sup>**. Production fees will not be refunded for any reason.

6. If you are notified of your child's selection for the company, you must complete enrollment by registering and paying for the appropriate Company Rehearsal Class by **Saturday, August 20, 2022**. Tuition for the class is included in our Carte Blanche program (production fees are not covered in the Carte Blanche program). Registration for Company Rehearsal Classes may be completed online by logging into your account at [www.dancenter-north.com](http://www.dancenter-north.com) or by calling the studio during regular business hours.

7. Performer's parents/guardians are required to accumulate the necessary number of BRAVO! points in support of the performers and the productions. Failure to do so will result in the student's ineligibility to audition for future DCN productions. Details about BRAVO! can be found on page 3.

## 2023 SPRING BRAVO! PROGRAM

The Spring BRAVO! program is for parents and guardians of performing company cast members (excluding The Magic of the Nutcracker). Volunteering during the performing season is required (and fun!). BRAVO! jobs are first come, first served. Sign up takes place online through [www.signupgenius.com](http://www.signupgenius.com). The link for the 2021 BRAVO! sign up will be sent in February 2022 via email to all parents/guardians listed on the audition application. Parents can volunteer for any combination of jobs in order to fulfill their required points.

**A minimum of 30 points is required for one Spring Company cast member.** A second child in the cast requires an additional **15 points**. Please take into consideration that many families choose to exceed the required number of points, as they are aware of the intricacies and difficulties of producing such high quality productions. If you are able to do additional work in any area of need, it is always appreciated! As they say, "Many hands make light work!"

There are five categories for volunteers to engage in supporting the productions.

- A. **PRE-PRODUCTION:** costuming, sets, props
- B. **TRANSPORT:** load-in, load-out, laying dance floor, strike
- C. **MARKETING:** poster distribution, ad sales
- D. **PERFORMER WELFARE:** providing food for cast, setting up, serving
- E. **SHOWTIME:** dressing, make-up, stage monitoring, security, ushering, lobby sales

- \_\_\_\_\_ \_\_\_\_\_ I understand that the audition application and the contract must be fully completed, accompanied by a headshot and audition fee, and turned into the DCN office no later than Monday, August 16<sup>th</sup> at 4:00 pm. I understand that my audition fee will increase to \$10 if we do not meet the deadline.
- \_\_\_\_\_ \_\_\_\_\_ I understand that if notified of selection for the cast, I must complete my enrollment by registering for the assigned Company Rehearsal Class by Saturday, August 20<sup>th</sup> and pay the tuition associated with that class, as applicable.
- \_\_\_\_\_ \_\_\_\_\_ I understand the class/rehearsal attendance requirements as spelled out in this packet.
- \_\_\_\_\_ \_\_\_\_\_ I understand that it is my responsibility to check my personal performer file folder each time I come to the studio for any rehearsal scheduling, costuming information, or any other show-related information. In addition, I understand that it is my responsibility to frequently check the DCN virtual Green Room ([www.dancer-north.com/green-room](http://www.dancer-north.com/green-room)) for scheduling changes, updates, and general cast information.
- \_\_\_\_\_ \_\_\_\_\_ I understand that as a performing company member, I am expected to be a good role model and an ambassador of Dancer North. This means that I will exhibit good behavior at the studio, theatre, and all other venues. I will be a team player. I will be courteous to other students, guest artists, teachers, directors, staff members, and BRAVO! volunteers; whether at Dancer North or other locations. I also understand that any inappropriate behavior, including gossiping, complaining, or bullying, will result in a personal conversation with the directors and may lead to removal from the cast.
- \_\_\_\_\_ \_\_\_\_\_ I understand that if accepted as a cast member, a non-refundable production fee of \$280.00 (Jr Company) or \$315.00 (Sr Company) is due no later than Monday, October 3<sup>rd</sup>. Additionally, I understand that my fee will not be refunded for any reason, related or unrelated to the current pandemic, or if rehearsals and/or performances must cease entirely for health and safety reasons. The production fee includes, but is not limited to, the following: casting sessions, costumes, choreography, extra rehearsal time, stage rehearsals, outside venue insurance, storage rental, warm-up classes, administrative staff, backstage supplies, janitorial supplies, wardrobe supplies, sewing supplies, make-up, and additional room rentals.
- \_\_\_\_\_ \_\_\_\_\_ I understand the requirements of the Spring BRAVO! program. If my child is selected for the cast, I commit to accumulating a minimum of 30 points in support of the production. I commit to accumulating an additional 15 points if I have a second cast member in the production. If I fail to do so, my child will not be eligible to audition for future productions at Dancer North.
- \_\_\_\_\_ \_\_\_\_\_ I understand that for the privacy of our families, no unauthorized videos or photographs may be posted online or on social media without the direct consent of the studio director.
